2. Do you support artificial formation of human life outside the womb for the purposes of cloning or fertility treatment, such as invitro fertilization and embryonic stem cell research?
3. Do you believe that at the moment of fertilization there is a living, unique and unrepeatable human being present in the womb?
4. Is it permissible to abort due to economic circumstance, sex selection, or any deformed or diseased babies, such as down syndrome or other?
5. Is it permissible to intentionally abort a baby to “save” the life of a mother?  
Examples of necessary procedures that result in unintentional abortion: ectopic pregnancies, uterine cancer, etc.
6. Will you advocate for and support government efforts that recognize and uphold the inalienable right to life, endowed by Our Creator, for unborn children from the moment of fertilization?
7. Would you ever accept money from any group or PAC that supports abortion, euthanasia, assisted suicide, or biological research involving aborted fetal tissue?
8. Will you work politically to end the trafficking of all baby body parts obtained from abortion for research of any kind?
9. Will you work to protect the rights of pro-life advocates as they demonstrate peaceably and legally against all abortion providers/workers, medical professionals, escorts, judges and others who promote or provide abortion and euthanasia?
10. Will you support and endorse legislation that provides conscience protection or exemptions to health-care providers, or any citizen, so they are free from statutory and regulatory mandates that would otherwise require them to provide, participate in or make referrals for services, medicines or “vaccines” or experimental vaccines that conflict with their morals?
11. Will you support legislation that removes the current Federal mandate that forces nearly every healthcare plan in the country to include “free” coverage of abortifacient birth control and sterilization as well as education and counseling on these “preventative services”?
12. Do you support a ban of all tax-payer funding of PP and other abortion providers through Medicaid or other state or federal funding?
13. Do you oppose all euthanasia, all assisted suicide, and all so-called mercy killing of innocent human life, including starvation by denial of food and water?
